Dear Parents / Guardians,

Re: Secondary School Places Allocation (SSPA) 2018/2020 Application for Cross-Net Allocation (Final Batch Applications)

The final batch of applications for cross-net allocation for the SSPA 2018/2020 is now invited. If a Primary 6 Student would like to change his/her school net, his/her parent may apply for cross-net allocation via his/her primary school by completing the attached "Application Form for Cross-Net Allocation". Please read the "Notes on How to Complete the Application Form" printed overleaf before completing the form.

- (a) The applicant should be the parent / guardian of the student in the record kept by school and live with the student in the same residential address.
- (b) To facilitate the planning of the provision of Secondary 1 school places in each school net for central allocation, those students who are in need of applying for cross-net allocation should complete the application form and submit it with copies of relevant proof documents to school as early as possible. The parents concerned are also required to present the original copy of the documentary proofs to the school for validation.
- (c) The applying student's residential address should be his/her only or principal place of residence, i.e. a dwelling place at which the applicant student resides and which constitutes his/her sole or main home. Acceptable residential address proof documents include stamped tenancy agreement, demand note for rates and/or government rent, tenancy agreement or tenant's rent card issued by the public housing authorities, residential telephone bill, and the bills from various utility companies, like Town Gas, Hong Kong Electric Company Ltd., Water Supplies Department, etc. Other documents such as bank's statements and mobile phone bills will not be accepted.
- (d) The name and address of the parent/guardian (i.e. the payee) must be printed on the residential address proof document. After validating the application form and the relevant proof from parents, the school will enter on the form 'Application for Cross-Net Allocation' (to be completed by school only) the district that the student concerned has applied to be changed to for central allocation.
- (e) If necessary, the Bureau will contact the parents/guardians concerned direct to confirm the correctness of the supporting documents. The parents/guardians may also be required to make sworn declarations. During the verification process, if a parent/guardian cannot provide the necessary documents or refuse to make a sworn declaration, the application for cross-net allocation will not be approved. The student can only participate in the central allocation in his/her original school net.



- (f) If a student has submitted application(s) to secondary school(s) for discretionary place(s) before applying for cross-net allocation and the parent wishes to cancel the discretionary place application(s), he/she should also indicate it on the application form and inform the secondary school(s) concerned in writing of the cancellation. A copy of the cancellation letter(s) should be handed in to the primary school with the application form for onward transmission to the Education Bureau for processing.
- (g) During the computer procedure of Central Allocation, the school net allocation band of the student approved for cross net allocation may be different from the one in his/her original school net since his/her score will be compared with the scores of the students in the new school net.

In view of the latest situation of the epidemic in order to hand in this reply slip, Parents are required to email school (pri@st-johannes.edu.hk) or Fax at Tel: 23362097 on or before 27th February 2020 to confirm if your child/ward is applying or not for the Cross-Net Allocation.

If your child/ward is applying for the Cross-Net Allocation, please fill in the application form for Cross-Net Allocation and hand in to school by post mail with an acceptable residential address proof document <u>on or before 27th February 2020.</u>

申請跨網派位 Application for Cross-Net Allocation 家長/監護人填表須知 Notes on How to Complete the Application Form

- 1. 申請人須為學校紀錄中的家長或監護人,並且與學生居住於同一居所。
 The applicant should be the parent or guardian of the student in the record kept by school and live with the student in the same residential address.
- 2. 本表格是供小六學生申請更改學校網之用。請注意,跨網派位只適用於統一派位乙部的學位分配, 而在自行分配學位階段和統一派位甲部的學位分配,均不受學校網限制。詳情請參閱「中學學位分 配辦法簡介」單張。

This form is provided for a P6 student who would like to change his/her school net. Please note that the Discretionary Places stage and Part A of Central Allocation (CA) are not restricted to school net. Hence, this cross net allocation is only applicable to Part B of CA. Please refer to the Information Leaflet on the Secondary School Places Allocation System for the details.

- 3. 有需要申請跨網派位的學生應向學校提交由家長或監護人已簽署的跨網派位申請表及有關證明文件的副本。家長或監護人亦須向學校出示有關證明文件的正本,以供學校核對。
 Students who are in need of cross-net allocation should submit the application form duly signed by their parents or guardians with copies of relevant proof documents to the school for onward transmission to the Education Bureau for processing. Parents or Guardians are also required to present the original copy of the documentary proofs to the school for validation.
- 4. 申請學生的居住地址是指申請學生的唯一或主要居所。獲教育局認可的居住地址證明文件包括已蓋 釐印的租約、徵收差餉及/或地租通知書、公屋租約/租用證及租咭、住宅固網電話收費單,以及各 公用事業機構,如煤氣及電力公司以及水務署發出的單據等。其他文件如銀行結算單及流動電話費 帳單將不獲接納。

The applying student's residential address should be his/her sole or chief residential address. Acceptable residential address proof documents include stamped tenancy agreement, demand note for rates and/or government rent, tenancy agreement or tenant's rent card issued by the public housing authorities, residential telephone bill, and the bills from various utility companies, like Towngas, HK Electric Company Ltd., Water Supplies Department, etc. Other documents such as bank statements and mobile phone bills will not be accepted.

- 5. 居住地址證明文件上必須載列家長或監護人(亦即繳納人)的姓名及地址。
 The name and address of the parent or guardian (i.e. the payee) must be printed on the residential address proof document.
- 6. 學校核實家長或監護人提交的申請表及有關證明文件後,會把申請轉交教育局。有需要時,教育局會直接聯絡有關家長或監護人,查核所提供申請資料的準確性,或要求有關家長或監護人作出宣誓,以資證明。核實資料的過程中,如家長或監護人未能提交教育局所需要的資料或作出宣誓,有關跨網派位申請將不獲批准,學生將會在其原來所屬學校網參加統一派位。

The school will submit this form to Education Bureau after validating the application form and the relevant proof documents from parents. If necessary, Education Bureau will contact the parent/guardian direct to confirm the correctness of the supporting documents. The parent/guardian may also be required to make a sworn declaration. During the verification process, if the parent/guardian cannot provide the necessary documents or refuses to make a sworn declaration, the application for cross-net allocation will not be approved. The student can only participate in the Central Allocation in his/her original school net.

7. 如學生在申請跨網派位前曾向一所或兩所中學提交了自行分配學位申請,而又需要取消有關申請, 家長或監護人須同時在跨網派位申請表註明及以書面向有關中學取消該項申請,並將信件副本連同申請表交小學,以便學校轉交教育局跟進。

If a student has submitted application(s) to secondary school(s) for discretionary place(s) before applying for cross-net allocation and the parent/guardian wishes to cancel the discretionary place application(s), he/she should also indicate it in the application form and inform in writing direct to the secondary school(s) concerned. A copy of the cancellation letter(s) should be handed in to the primary school with the application form for onward transmission to the Education Bureau for processing.

If a student studying in a feeder/nominated primary school is approved for cross-net allocation, he/she will not be eligible for a reserved place of the feeder/nominated secondary school(s).
